Funded childcare hours for children of working parents - apply in plenty of time

If you are an eligible working parent, you can apply for:

- √ 15 hours childcare per week over 38 weeks of the year, if you have a child between 9 months old and 3 years old. Your child must be at least 9 months old on or before 31 December.
- √ 30 hours childcare per week over 38 weeks of the year, if you have a child aged 3 or 4 years old.



Apply now to get your funded childcare code to start in January 2025.

If you plan to return to work from parental leave or start a new job by the **end of January**, you can also apply now for a childcare code. You will then receive a letter in the post within 1 to 2 weeks. For further information visit: https://www.gov.uk/apply-free-childcare-if-youre-working
